Qualifications and Uses

Purpose:

The Second Church Fund Scholarship program exists in order to support members of Second Presbyterian Church in their pursuit of higher education by awarding annual college/trade school scholarships.

Scholarship Type:

The SCF Scholarship(s) given are grants with no requirements for repayment.

Student Criteria:

- The student must be a graduating senior of an accredited high school and be registered or accepted for admission to an approved college or university, junior college, technical college, or trade school with a two-year minimum program.
 The student must have a minimum cumulative GPA of 3.0 (4.0 scale)
 The student and/or parent(s)/legal guardian must be a member of Second Presbyterian Church for at least one year prior to the application deadline OR the student must demonstrate service and commitment to Second Presbyterian Church.

Alternative Student Criteria:

- The student must have an alternative/equivalent to high school graduation and be registered or accepted for admission to an approved college or university, junior college, technical college, or trade school with a two-year minimum program.
 The student and/or parent(s)/legal guardian must be a member of Second Presbyterian Church for at least one year prior to the application deadline OR the student must demonstrate service and commitment to Second Presbyterian Church.

Scholarship Uses:

The SCF Scholarship money must be used for tuition and/or room and board.

Applications:

Information and applications are available in the church office and on the church website. Applications must be returned in their entirety as specified by the application to the church office by **APRIL 1**

Scholarship(s) Awarded:

There will be 6 Scholarships awarded each year. The SCF Scholarship(s) given will be in the amount of \$1,500 per student. If there are more than 6 scholarship applications each year, High School and/or College/Trade School, the applications will be graded on the following scale.
